DURING THE REPORTING PERIOD, SERVICES WERE PROVIDED IN 11 JUVENILE DETENTION CENTERS ACROSS EL SALVADOR, GUATEMALA, AND HONDURAS. THROUGH THE SUCCESS ACADEMY, YOUTH PARTICIPATED IN STRUCTURED PROGRAMMING THAT INCLUDED LIFE SKILLS TRAINING, LEADERSHIP DEVELOPMENT, BIBLE-BASED CHARACTER FORMATION, AND VOCATIONAL WORKSHOPS.
